**RESOLUTION TO ESTABLISH NO PARKING AREAS
AND PLACEMENT OF STOP SIGNS**

WHEREAS, the Town of Liberty Town Board, in the interest of public health and safety, finds it necessary and appropriate to regulate parking and stop signs within the Town at designated intersections as described in this resolution; and

WHEREAS, the Town Board has the authority to adopt these regulations pursuant to Section 60.10, Wis. Stat., as a reasonable exercise of its police power provided thereby, and pursuant to Sections 349.065 and 349.13, Wis. Stat.;

NOW, THEREFORE, BE IT RESOLVED, by the Town Board of the Town of Liberty, Manitowoc County, Wisconsin, as follows:

1. **RESTRICTIONS ON PARKING.** The following area is designated as a "NO PARKING" area at all times: A portion of Pigeon Lake Road, located in Section 33, Township 18 North, Range 22 East, in the Town of Liberty, Manitowoc County, Wisconsin, being the east and north side of Pigeon Lake Road extending from its intersection with North Shore Drive, to the east and south to a point 550 feet more or less south of the intersection of Pigeon Lake Road and Autumn Ridge Drive.

2. **STOP SIGN INTERSECTIONS.** The following intersections within the Town of Liberty, Manitowoc County, Wisconsin, shall be properly marked with stop signs. A stop sign shall be erected as follows:

- A. On Rogne Road at the intersection with Marken Road.
- B. On Hillcreek Road at the intersection with Marken Road.
- C. On Rose Lawn Road at the intersection with Marken Road.


- D. On Rose Lawn Road at the intersection with Boldt Road.
- E. On Madson Road at the intersection with Newton Road.
- F. On Selle Road at the intersection with Carstens Lake Road.
- G. On Selle Road at the intersection with Wehausen Road.
- H. On Carstens Lake Road at the intersection with Nagel Road.
- I. On Viebahn Road at the intersection with Range Line Road.
- J. On Robley Road at the intersection with Lenz Road.
- K. On West English Lake Road at the intersection with Tompkins Road.

BE IT FURTHER RESOLVED, that the Town Board shall arrange for the erection of signs according to all applicable ordinances, statutes, and motor vehicle code for the purpose of carrying out the terms of this resolution.
